I am opposed to the 2 story 7600 square foot addition on the existing property of Echo.I have lived at Ave, just a few hundred feet from Echo and my apartment is located on the street side, across from ABC (Atascadero Bible Church).

You plan to increase the number of clients serving beds from 60 to 90, occupancy from 80 to 100 and shower operations to 15 hours per week.

I have lived at my location for over 10 plus years. The following reasons of why I am opposed to the Echo building project:

- (1) Echo has limited parking on their premises and this results in an overflow of homeless cars and persons camping on the median (historical landmark).
- (2) The Atascadero Police as a result of (# 1) above has had to spend time in removing the homeless campers (camping gear and trsh).
- (3) I have also seen the homeless camping on the River bank near Atascadero Avenue and El Camino Real with tents and trash.
- (4) On Atascadero Ave their is limited parking as it relates to ABC Church, North County Christian School, Atascadero High School, and the general public.

Allowing the project to move forward would increase the homeless problem as outlined above. If the National Guard Armoury (mentioned this to Ryan Hayes 1 1/2 yeas ago) is still vacant you should move the homeless shelter to those pemises.

Finally, the proposed project drawing does not address the construction of additional parking on the Echo Homeless Shelter pemises, this should be addressed and included in the plans and at the very least taken seriously at your upcoming meeting.

I live two blocks from the ECHO facility and have seen their consistent improvement over the years so I have no worries in my mind about the neighborhood or level to which they operate that facility in the neighborhood. I have reviewed the proposed plans, they will greatly improve their ability to serve the unhoused community and will reduce the number of unhoused people on the streets of Atascadero. I am writing to you in support of the ECHO expansion project.

ECHO has a proven track record and their statistics speak for themselves. They are fulfilling a massive need in our community by providing one of the lower rungs to the "housing ladder". They see hundreds of people each year graduate from their shelter to permanent housing.
