HOW TO SUBMIT PUBLIC COMMENT:

Public comment may be provided by connecting to the webinar, as described above, or written public comments may be submitted to <u>cityclerk@atascadero.org</u> by 3:00 pm on the day of the meeting. Such email **comments must identify the Agenda Item Number in the subject line of the email**. The comments will be read into the record, with a maximum allowance of 3 minutes per individual comment, subject to the Chairperson's discretion. All comments should be a maximum of 500 words, which corresponds to approximately 3 minutes of speaking time. If a comment is received after the agenda item is heard but before the close of the meeting, the comment will still be included as a part of the record of the meeting but will not be read into the record.
