It's an exciting opportunity to make the Centennial Plaza area in the Sunken Gardens a magnet for families, travelers, and our community. A playground with public bathroom, similar to Paso Robles, brings more people downtown, provides restroom facilities for events and the farmers' market, and creates a gathering spot that will increase revenue in local businesses.
