

As a resident of Atascadero and business owner within SLO County I would like to voice my support for the El Camino Real Downtown Infrastructure Enhance Plan for future roadway improvements. It was highlighted that the priorities are to increase public safety as well as increase available parking in the area immediately next to Sunken Gardens and the future La Plaza Development. Not only will increased pedestrian safety encourage more people to walk around the growing downtown area (increasing spending and sales tax dollars) but the slowed automobile traffic will allow passersby to catch a better glimpse of the new retail, restaurants, etc. ultimately leading to increased interest in the area. To give an even more pointed opinion I would suggest moving forward with a plan that optimizes the space used to allow for the most parking. Honorable Councilmembers:

Thank you for the foresight of imagining a safer and more attractive downtown. In tomorrow's meeting I am sure you will get some points of view that don't share my conviction that tonight's approval is needed. The improvements are absolutely essential for our downtown to reach it's potential and protect the safety of our residents.

What many of the people that are opposed to the improvements don't realize is that El Camino in the present configuration is extremely dangerous. When I worked on the bike plan for Atascadero, it was my job to map the accidents that made it to the police reports. Keep in mind that the accidents actually reported are only a fraction of the total number of accidents. The largest concentration of bike/car accidents by far, was the area of consideration. In addition, the number of cars hitting pedestrians in front of Klems gas station is unacceptable. I have spent a lot of time downtown in the last three years and I know first hand the danger of the present configuration.

The main design flaw is the width and straight alignment. It gives motorists the confidence to break the speed limit. Speed bump be damned. The second design flaw is that with two lanes moving in the same direction it allows one of the cars to block the view of the second car. The result is screeching tires or pedestrians sent to the hospital. Kids are not always paying

enough attention when they cross and for them it is particularly dangerous. 15 cars hitting pedestrians in the crosswalk is 15 too many. That is disastrous for business.

There are whole websites dedicated to walkability. The improvements under consideration would make Atascadero a lot more walkable.

It is our duty to protect our residents and we are letting them and our youth down if we don't approve the plan without further delay.

A few comments about the plan:

- 1. I would suggest that some of the centralized parking / flex space be changed out to landscaping to break up some parking aesthetic. There is some in the plan but needs more.
- 2. May want to consider the use of some back-in angled parking as a way to provide visual intercepts for bike riders and cars pulling out of spaces along the street corridor. Add the "cool" to the downtown corridor.
- The City might want to consider a detailed subsurface infrastructure planning effort, not as attractive, but some of the infrastructure for projects in the downtown corridor is old or non – existent such as storm drain infrastructure. Please accept the following comment for Agenda Item C 1

I am a professor at Cal Poly and an Atascadero resident since 2015. When I first heard of the proposed project to reconfigure El Camino Real to increase parking by constricting traffic flow, I initially opposed the idea based mainly on expected effects on traffic flow through downtown. I now strongly endorse this plan, and I would like to say a bit about why this proposed plan would improve Atascadero.

In the few years I've lived in Atascadero the downtown has been revitalized with new businesses providing compelling reasons to be downtown rather than just pass through the downtown to go somewhere else. This plan provides residents and visitors an effective means to utilize the downtown region as a destination. Additional parking on El Camino supports the growing trend of seasonal events in the downtown, which typically restrict parking when Traffic, Entrada, and the roads around the Sunken Gardens are closed off.

To accommodate for the center median parking spaces obviously restricts traffic flow. This mainly affects travelers not interested in the downtown as a destination but merely passing through. Those who use El Camino to move north or south through town are already regularly frustrated by delays from the intersections around Highway 41, which would remain as they currently are regardless of structural changes several blocks north of that constriction. Thankfully, access to Highway 101 would remain the better option for traversing through downtown to somewhere else.

The time is right to improve access to the businesses downtown. We are all struggling with the emerging economic crisis accompanying a global pandemic. Acting now to improve our downtown would set the stage for the inevitable economic recovery. The small-business community that has

already committed to the transformation of downtown will need potential customers to see the convenience of conducting their business downtown for their businesses to survive this economic downturn.
